BARCELONA MINIATURAS FAIR MARCH 2023 CONTRACT

This document provides that Cosa de 3 S.C. with CIF J65657157 (Hereinafter the Organization) and the

Exhibitor, contract by mutual agreement

To loan a table and exhibit at the Barcelona Miniaturas Fair, under the following

TERMS

<u>FIRST</u>.- The Organization provides the Exhibitor with a table or tables as stated in the inscription form, with the characteristics and price stated in said inscription form. The inscription must be approved by the Organization, and will not be automatic in any way.

<u>SECOND</u>.- Once the inscription is approved, payment will be made by the Exhibitor by Bank Transfer to the CAIXA GUISSONA Bank account : **IBAN ES84 3140 0001 97 0016234900**, (**BIC BCOEESMM140**), or at the **PayPal account** <u>barcelonaminiaturas@gmail.com</u>

Paypal commissions will be supported by the Exhibitor. Payment must be completed for the Exhibitor to be considered as fully participant in Barcelona Miniaturas Fair.

<u>THIRD</u>.- The Exhibitor provides his/her personal data by filling the inscription form in the website <u>https://www.barcelonamadridminiaturas.com</u>. This data will be solely used for information purposes around the Barcelona Miniaturas Fair, and also to inform the Exhibitor about other activities organized by Cosa de 3, S.C. This data will be treated according to the Spanish Protection Data Law, and the rights derived from said law can be exercised by writing an email to <u>barcelonaminiaturas@gmail.com</u>

FOURTH.-The Organization undertakes

- To advertise the Fair in all possible media and in its social media accounts.
- To reach an agreement with the Hotel in which the Fair takes place, to provide preferential accommodation conditions for exhibitors.
- To provide enough set up and dismantling time

The exhibitor undertakes

- To send all requested advertising material, in the requested deadlines. If the material is not sent, or if it is sent later than the requested deadline, the Organization is not required to include the Exhibitor in the general or social media advertising.
- To respect the set up and dismantling times.
- During the Fair, set up or dismantling, to address any tool or material request to the Organization and not to the Hotel personnel directly. In case of non-compliance, if this petition carries extra costs for the Organization, those extra costs will be borne by the Exhibitor.

<u>FIFTH</u>.-_The Organization undertakes to provide the table or tables, two chairs per table, one identifying sign for the table, and two small ones for personal use. Tables will have access to plugs, but it is recommended to bring your own extension cords.

<u>SIXTH</u>.- The Organization distributes all exhibitors in the Fair Room according to their products. Nevertheless, if possible and by inscription order, petitions for a certain location will be taken into consideration.

<u>SEVENTH</u>.- The Exhibitor undertakes to inform the Organization if he/she will be showcasing pieces from other exhibitor not present at the Fair. Thus, the second exhibitor will be advertised as represented by the first. If two exhibitors want to share a table, they must contact the Organization for its approval. In a similar way, if the Exhibitor wants to book half a table, it must be approved by the Organization.

<u>EIGHTH</u>.-_It is not allowed to smoke or drink alcoholic drinks in the Fair Room.

<u>NINTH</u>.- It is strictly forbidden to let visitors behind your exhibition table.

Also, any security measures implemented by local health authorities will be mandatory for Organization, visitors and Exhibitors. The Organization undertakes to inform Exhibitors about any change in this security measures.

<u>TENTH</u>.-<u>The Organization is not responsible in any way for the Labour, Tax or Social Security situation of the Exhibitor or the people with whom he/she is sharing a table or the people who help with sales.</u>

ELEVENTH.- In case of cancellation:

- a) If the Exhibitor cancels, the price of the table will not be returned. If the cancellation is due to Force Majeure (art. 1105 of the Spanish Civil Code) with documented proof, the price will be returned if the cancellation occurs until January 20th 2024. If the cancellation occurs later than that date, the price will be counted as reservation for the next edition of Barcelona Miniaturas. If the price rises in the next edition, the difference must be paid. If the price lowers, the Exhibitor will not be entitled to a compensation.
- b) If the Fair is cancelled by the Organization, due to its free will or to Force Majeure, the price will be returned to the Exhibitor.

<u>TWELFTH</u>.- If the Fair has to change dates, or if exceptional circumstances or the rules implemented by authorities on account of those exceptional circumstances make extremely complex or costly the Fair or the exhibitors assistance, the Organization will offer alternatives to all exhibitors, and follow their majority decision.

<u>THIRTEENTH</u>.- For any disagreement or breach of this contract, the above stated parts submit to the jurisdiction of the Courts of Barcelona.

<u>FOURTEENTH.-</u> Participation in the Fair implies the full acceptance of the present contract.
